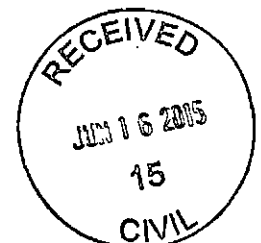

1 The default of defendant Matt McLaughlin having been duly entered, and the Court having
2 determined that plaintiff Kamala D. Harris, in her official capacity as Attorney General of the
3 State of California, is entitled to the relief requested in her complaint for declaratory relief based
4 upon the request for entry of default judgment (form CIV-100) and the memorandum of points
5 and authorities in support of request for entry of default judgment and evidence submitted in
6 support of that request, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:


7 1. The proposed initiative titled the "Sodomite Suppression Act" (the "Act") is patently
